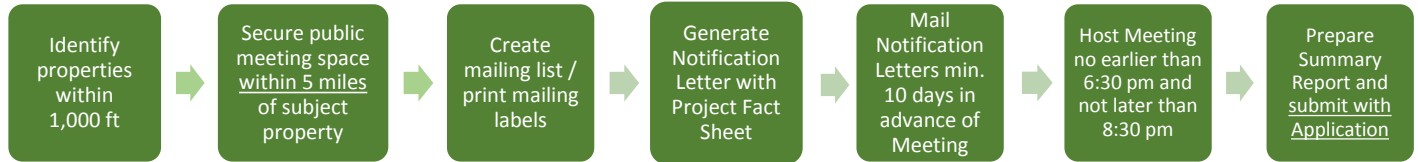


2018 CHEROKEE COUNTY REZONING PROCESS & PUBLIC HEARING CALENDAR

Application is Accepted or Rejected (within 5 business days after submittal)

Zoning Review Meeting

Once Accepted, Staff will meet to review and comment on essential parts of plan and application. Review comments will be provided within 5 days of the meeting. When the plan and application are whole, staff will deem the application complete and schedule it for a public hearing.

Application Deemed Complete

THERE IS NO FILING DEADLINE – Only applications Deemed Complete will move on through the schedule below for public hearing. The applicant or their representative must be present at the public hearing.
