Woodstock Man Sentenced to Prison for Trafficking Fentanyl and Methamphetamine *State vs. Quentodd Montell Pinkins*

CANTON, GA (July 14, 2026) – District Attorney Susan K. Treadaway announces that Quentodd Montell Pinkins, 35, of Woodstock, entered a negotiated guilty plea on June 2 to multiple drug charges and was sentenced to 30 years, with the first 15 years in prison and the remainder on probation.

Pinkins pled guilty to:

- Sale of fentanyl (3 counts)
- Illegal use of communication facility (3 counts)
- Trafficking fentanyl (3 counts)
- Trafficking methamphetamine (1 count)

These charges stem from a 2025 investigation by the Cherokee Multi-Agency Narcotics Squad (CMANS), which began after investigators received information indicating that Pinkins was distributing fentanyl and methamphetamine in Woodstock.

During the investigation, undercover CMANS agents conducted four controlled purchases in which Pinkins sold fentanyl at locations near Highway 92 in Woodstock.

The fourth controlled purchase occurred on March 19, 2025, when Pinkins sold approximately 7 grams of fentanyl. Later that day, Pinkins was taken into custody, and the Cherokee County SWAT team executed search warrants at his residence and vehicle. CMANS agents recovered fentanyl, methamphetamine, marijuana, ecstasy, cocaine, a digital scale, cards containing trace amounts of fentanyl, a Smith & Wesson .357 revolver, and \$1,411 in cash.

“Each controlled purchase strengthened the case against the defendant and led investigators to recover trafficking quantities of fentanyl and methamphetamine,” said Assistant District Attorney Leland McElveen, who prosecuted this case on behalf of the State. “This defendant showed a complete disregard for public safety by brazenly conducting drug deals in plain sight in the Walmart and Wendy’s parking lots.”

Testing by the GBI Division of Forensic Sciences confirmed that the substances recovered during the investigation included trafficking quantities of fentanyl and methamphetamine.

Superior Court Judge Shannon Wallace sentenced Pinkins in accordance with the negotiated plea, ordering him to serve 30 years, with the first 15 years in prison and the remainder on probation. He must also pay a \$200,000 fine and comply with special conditions of probation.

“Fentanyl continues to devastate families and communities across Georgia,” said District Attorney Susan K. Treadaway. “Those who profit from distributing this deadly poison should expect significant prison sentences. We will continue working with our law enforcement partners to hold traffickers accountable and keep these dangerous narcotics off our streets.”

The case was investigated by the Cherokee Multi-Agency Narcotics Squad, with assistance from the Cherokee Sheriff’s Office, the Cherokee County SWAT team, and the Georgia Bureau of Investigation. Assistant District Attorney Leland McElveen, Office of the District Attorney, Blue Ridge Judicial Circuit, prosecuted the case.
