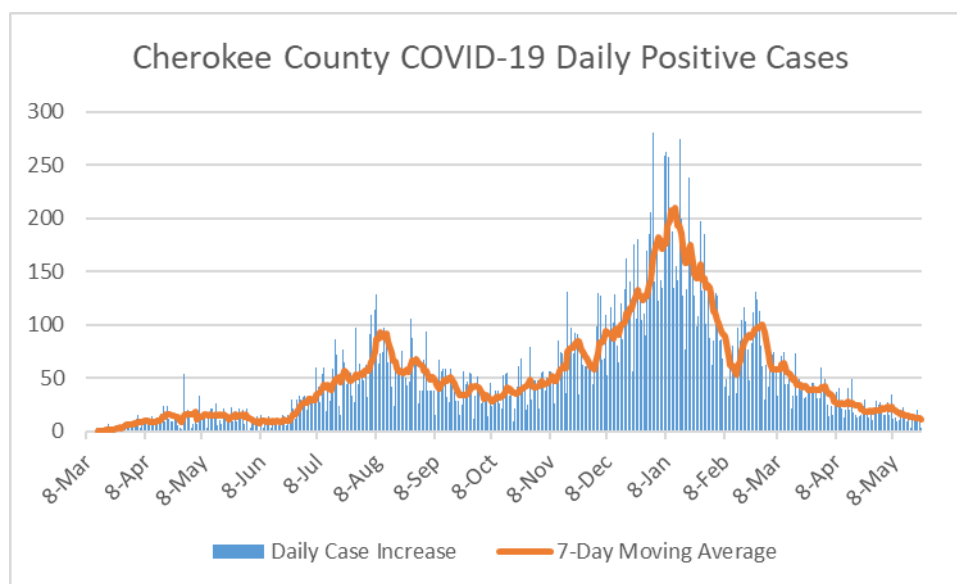


**CHEROKEE COUNTY EMERGENCY MANAGEMENT AGENCY

**DAILY UPDATE**

- Cherokee County EMA and Board of Commissioners ask that you be mindful of your needed travels, contact with others, continue to practice social distancing, and practice good hygiene.
- The Georgia Department of Public Health has announced 893,624 confirmed cases of COVID-19 across the state.
- 17,930 deaths have occurred in the state as a result of COVID-19.
- Cherokee County has 22,640 confirmed cases of COVID-19, since March 8, 2020. This is an increase of 2 cases from the previous day.
- Cherokee County has three hundred and seven (307) confirmed fatalities due to COVID-19.



**\*\*\* COVID-19 Vaccination Clinic Location\*\*\***

- The COVID-19 vaccination clinic is located at Canton First Baptist Church. The church is located at 1 Mission Point, Canton, GA 30114.
  - **ALL Georgian's aged 16 and older are eligible for the vaccine.**
  - **The schedule at the Canton First Baptist Church Vaccination Clinic has changed. The new schedule will be Monday through Thursday, 8:00 am to 3:30 pm.**
  - To make an appointment with Georgia DPH in Cherokee County, eligible residents should register via the following methods:

    - The DPH Vaccine Scheduling Resource Line at (888)-457-0186. Monday through Friday 8:00 am – 5:00 pm. Saturday 8:00 am – 5:00 pm.
- Beginning on Tuesday, May 11<sup>th</sup>, Georgia Public Health will offer a Family Night COVID-19 Vaccine Clinic at the Canton Health Department location. The address is 1219 Univeter Road, Canton, GA, 30115. Hours for this event will be 4:00 pm until 6:00 pm. No appointment is needed.

**\*\*\* COVID-19 drive-thru testing location\*\*\***

- COVID-19 testing will now be administered by Mako Medical instead of Georgia Public Health. The new drive-thru testing site is located at First Baptist Church of Woodstock, in a parking lot adjacent to Gunnin Road. **Please note: entrance to the testing site will need to be made via Gunnin Road.** Hours of operations and pre-registration processes are listed below:
  - Days/Hours of Operation: Monday-Friday from 8:00 AM until 3:00 PM
  - You are only required to pre-register for your test. There are no set appointment times. As soon as you sign up for testing, you can arrive at the testing site any time between

- 8:00 AM and 3:00 PM that is convenient for you.

- The Georgia Department of Public Health has established an Emotional Support Line. They will provide 24/7 free and confidential assistance to callers needing emotional support or resource information as a result of COVID-19. The number is 866-399-8938.
- The Cherokee County Aquatic Center has begun a phased reopening of its pools for the general public. Please contact the Aquatic Center for additional details at 678-880-4760.
- Local parks and trails remain open to the general public. Please utilize the following guidelines for park use.
  - Follow CDC's guidance on personal hygiene prior to heading to parks and trails — wash hands, carry hand sanitizer, do not use parks or trails if you have symptoms, cover your mouth and nose when coughing or sneezing, etc.
  - Warn other trail users of your presence and as you pass to allow proper distance and step off trails to allow others to pass, keeping minimum recommended distances at all times. Signal your presence with your voice, bell or horn.
  - Note that trail and park users may find public restrooms closed — be prepared before you leave and time outings so that you are not dependent on public restrooms.
  - Bring water or drinks — public drinking fountains may be disabled and should not be used, even if operable
  - Bring a suitable trash bag. Leave no trash, take everything out to protect park workers
- The Cherokee Family Violence 24/7 Hotline number is 770-479-1703 for English and 770-720-7050 for Spanish. The Cherokee Family Violence Center is providing emergency shelter for victims of domestic violence and assisting with emergency protection orders M-F 9am-5pm.
- The Courts of the Blue Ridge Judicial Circuit and Cherokee County will continue to operate under the Judicial Emergency Order governing operations of the Courts of this State. The Courts will remain open to address essential functions as provided under the Judicial Emergency Order.

The citizens of Cherokee County are resilient and have always stepped up to meet any challenge. We are all in this together!

## **PREVENTATIVE MEASURES**

- Wash your hands often with soap and warm water for at least 20 seconds. If soap and water are not available, use an alcohol-based hand sanitizer.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Stay home when you are sick
- If you are sick, please contact your primary care physician.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces.
- Practice social distancing
- Receive a flu vaccination
- All residents of Georgia are encouraged to have a plan in place to care for and protect family members who are elderly or have compromised immune systems. Check on neighbors who may be elderly or have a heightened risk of contracting the virus.
- We encourage citizens of the county to use take out or delivery options at restaurants.
