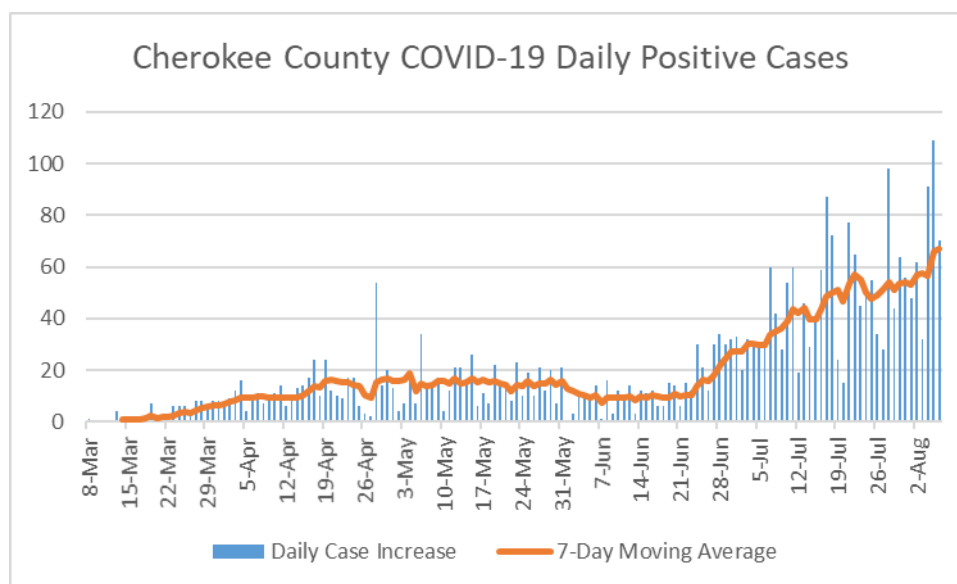


**CHEROKEE COUNTY EMERGENCY MANAGEMENT AGENCY

DAILY UPDATE

- Cherokee County EMA and Board of Commissioners ask that you be mindful of your needed travels, contact with others, continue to practice social distancing, and practice good hygiene.
- The Georgia Department of Public Health has announced 204,896 confirmed cases of COVID-19 across the state.
- 4,026 deaths have occurred in the state as a result of COVID-19.
- Cherokee County has 3,155 confirmed cases of COVID-19. This is an increase of 70 cases from the previous day.
- Cherokee County has fifty-eight (58) confirmed fatalities due to COVID-19.



- Reinhardt University, in partnership with Georgia Highlands Medical Services, will be offering free COVID-19 testing to the public on Thursday, August 13th, and Friday, August 14th from 8:00 am until 12:00 pm. The testing site will be located at the Falany Performing Arts Center, which is located at 7300 Reinhardt Circle, Waleska, GA 30183. To schedule an appointment, please call 470-758-8415. Due to an overwhelming volume of calls, please be advised that it may take multiple calls to get through.

- Governor Kemp has announced that all Georgians can be tested for COVID-19. Residents are required to use the following option to receive an appointment time and location for testing.

 - The Direct Patient Line Is available Monday through Friday (8:30am-5:00pm) and Saturday (8:30am-12:00pm).
- The City of Woodstock has issued Executive order #2020-6 requiring citizens to wear face coverings when entering and inside city buildings. Please see <http://www.woodstockga.gov/> for further information.
- The Cherokee County Senior Center is closed for activities but offices remain open. Citizens are asked to check the senior center's Facebook page at: <https://www.facebook.com/Cherokee-County-Senior-Services-368820693245811> for reopening updates or call 770-345-2675 for more information.
- The Georgia Department of Public Health has established an Emotional Support Line. They will provide 24/7 free and confidential assistance to callers needing emotional support or resource information as a result of COVID-19. The number is 866-399-8938.
- The Cherokee County Aquatic Center has begun a phased reopening of its pools for the general public. Please contact the Aquatic Center for additional details at 678-880-4760.
- Cherokee Recreation and Parks Agency (CRPA) has announced that all playgrounds, pavilions, athletic fields, and the Skate Park are open, with restrictions. All park users must continue to abide by all CDC guidelines on social distancing, as well as gathering sizes as defined by Gov. Brian Kemp's Executive Order.
- Local parks and trails remain open to the general public. Please utilize the following guidelines for park use.
 - Follow CDC's guidance on personal hygiene prior to heading to parks and trails — wash hands, carry hand sanitizer, do not use parks or trails if you have symptoms, cover your mouth and nose when coughing or sneezing, etc.
 - Observe at all times CDC's minimum recommended social distancing of six feet from other people. Practice it and know what it looks like. Keep it as you walk, bike or hike.
 - Warn other trail users of your presence and as you pass to allow proper distance and step off trails to allow others to pass, keeping minimum recommended distances at all times. Signal your presence with your voice, bell or horn.
 - Note that trail and park users may find public restrooms closed — be prepared before you leave and time outings so that you are not dependent on public restrooms.
 - Bring water or drinks — public drinking fountains may be disabled and should not be used, even if operable
 - Bring a suitable trash bag. Leave no trash, take everything out to protect park workers
- The Cherokee Family Violence 24/7 Hotline number is 770-479-1703 for English and 770-720-7050 for Spanish. The Cherokee Family Violence Center is providing emergency shelter for victims of domestic violence and assisting with emergency protection orders M-F 9am-5pm.
- The William G. Long Senior Center will remain closed until further notice.
- CATS has resumed on-demand services on Tuesdays and Thursday for grocery store and pharmaceutical trips. Clients should call CATS to schedule those trips. Social distancing requirements and sanitation protocols on all buses will continue. Service to the Senior Center, Empower Cherokee and other high risk facilities will remain closed until further notice.
- The Courts of the Blue Ridge Judicial Circuit and Cherokee County will continue to operate under the Judicial Emergency Order governing operations of the Courts of this State. The Courts will remain open to address essential functions as provided under the Judicial Emergency Order.

The citizens of Cherokee County are resilient and have always stepped up to meet any challenge.

PREVENTATIVE MEASURES

- Wash your hands often with soap and warm water for at least 20 seconds. If soap and water are not available, use an alcohol-based hand sanitizer.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Stay home when you are sick
- If you are sick, please contact your primary care physician.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces.
- Practice social distancing
- Receive a flu vaccination
- All residents of Georgia are encouraged to have a plan in place to care for and protect family members who are elderly or have compromised immune systems. Check on neighbors who may be elderly or have a heightened risk of contracting the virus.
- We encourage citizens of the county to use take out or delivery options at restaurants.
